The **Construction Industry Development Board (CIDB)**, a statutory body which operates under the aegis of the Ministry of Public Infrastructure and Land Transport, regulates and promotes the development and improvement of the construction industry. Established under the CIDB Act 2008, the organization has a comprehensive set of objects and functions which enable it to ensure the proper evolution of the construction industry.

In addition to aiming at providing leadership and guidance towards the development of a competitive and world class construction industry, CIDB caters for the registration of contractors, consultants, suppliers and service providers operating in the construction sector.

While playing an advisory role with regards to the sector to relevant authorities, CIDB also promotes sustainable growth by encouraging communication between stakeholders so as to make the construction industry more accessible and transparent.

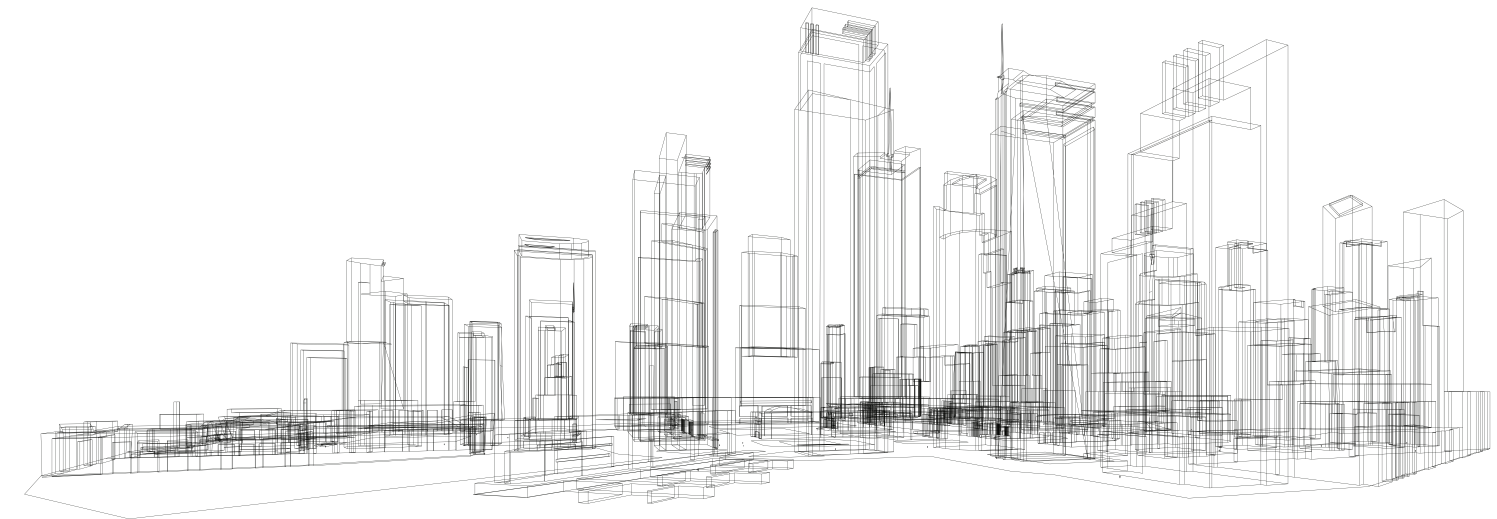

CIDB aims at promoting, assisting, facilitating and establishing the following objectives in the construction industry:

- development, improvement and sustainable growth of the sector
- the participation of small and medium enterprises
- the export of services
- quality assurance
- the awareness of the need for a safe and healthy work environment
- best practice
- research and development
- communication between stakeholders



Our functions

Implement government policy relating to the construction industry

Regulate and register providers of construction works and construction services and suppliers of construction materials, equipment, plant and labour for construction purposes

Register such construction projects as many be prescribed

Exercise regulatory functions in respect of the construction industry, including the registration of consultants and contractors

Provide advisory services to the construction industry and to the public in general

Publish an annual list of registered consultants and contractors

Advise and make recommendations to the Minister on matters relating to the construction industry

Encourage the standardization and improvement of construction materials and techniques

Develop standard forms of construction agreements and contracts

Develop and maintain a construction industry information system

Develop and promote training programmes for operators of the construction industry

Advise relevant authorities on human resources development of the construction industry

Conduct surveys on the construction industry

Entertain complaints in connection with construction works and construction services and where necessary refer them to appropriate authorities

Publish periodically indicative schedules of rates for construction works

Register providers of dispute resolution services in the construction industry



Our services

CIDB provides the following services to their Stakeholders and to members of the Public:

Registration of Consultants, Contractors, Suppliers and Service Providers of the construction sector

Advise on all matters related to construction

Develop standard forms of contract adapted to local conditions

Surveys and compilation of information on the construction industry in collaboration with other government authorities and private institutions

Trainings and workshops for capacity building in the industry

Entertain complaints related to construction works from the public

Development and publication of a National Schedule of Rates for use as a benchmark for construction rates

Guidance and assistance to small and medium enterprises in the sector

Assist consultants and contractors to export their services

Assist students in construction fields by giving them advice and providing information on construction in the course of their studies
