- (ii) The form of collaboration between a foreign contractor and a local contractor shall be a joint venture agreement, a subcontract agreement or any form of agreement between the contractors for execution of works under the project.
- (iii) The conditions of the collaboration agreement between a foreign contractor and a local contractor shall be based on their experience, capability, respective input in delivering the project, and the requirements of the project concerned.
- (iv) The apportioning of the contract price between a foreign contractor and a local contractor shall be commensurate with the value of works undertaken by each contractor.
